Dear Ms. Dortch:

The Enterprise Wireless Alliance ("EWA") is pleased that the 800 MHz rebanding proceeding is now complete¹ and that the Federal Communications Commission ("FCC") has lifted freezes that will allow additional spectrum in this band to be utilized.² There is one further step EWA recommends that will permit the full potential of the band to be realized. The FCC adopted rules in 2018 authorizing the creation of 12.5 kHz bandwidth interstitial channels in the 809-817/854-862 MHz band.³ It adopted an Order on Reconsideration in 2020 that modified and clarified the technical rules for coordinating applications for those interstitial channels.⁴ Thus, while the rules are in place to license systems on those channels, no filing window for accepting applications has been announced pending completion of 800 MHz rebanding.

The Post-Rebanding PN announced that the FCC would begin accepting applications for 800 MHz 25 kHz bandwidth channels on August 14, 2021. Those applications will have been coordinated by FCC-certified Frequency Advisory Committees ("FACs"), thereby ensuring that they meet all FCC requirements and are not mutually exclusive with other applications. After that date, the 25 kHz bandwidth spectrum environment in this band largely will be settled and the introduction of systems on 12.5 kHz channels may commence.

EWA urges the FCC to issue a Public Notice announcing a date as soon as possible after August 14, 2021, when it will begin accepting applications for 800 MHz 12.5 kHz bandwidth channels. The FACs that coordinate 800 MHz spectrum have determined that no special coordination process will be required to handle these applications, because it is not anticipated that they will be geographically concentrated. The standard frequency coordination process is well-equipped to handle any possible instances of mutual exclusivity, as it does today in the rare instances when those situations arise.
